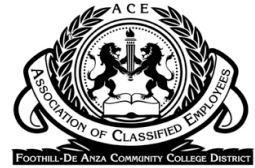


## ACE BOARD MEETING MINUTES

### OLD BUSINESS

#### Representation Letter

Bradley Booth handed out the Union Representation letter. A discussion ensued whereby it was agreed that both the Union and the Senate should both have voting rights. A list of Committees is to be given to President Monary and Bradley Booth.

PARC will not be allowed to get matter resolved until the voting issue is resolved. They must cease and desist.

Dave Garrido informed the Board that the Governance Handbook was set to be approved by PARC at the next PARC meeting. The Governance Handbook did not include membership / voting rights by the Classified representatives. Dave suggested that we get other unions to vote no on the handbook until PARC gets ACE membership on the committee with voting rights.

#### Appointment of ACE Board Member

#### Distribution of Release Time

A conversation was held with Kim Chief Elk on release time. Blanche will send Kim Chief Elk the assigned release time and Ms. Chief Elk will notify Managers.

#### Recorder Schedule

President Monary suggested a temporary increase in hours for the next three months. Financially this will mean a cost of \$704/week (\$2800/month or \$5600.00 for 3 months). It was agreed to grant the ACE Recorder 40 hours per week for one month. The Board deemed this enough time for the Recorder to catch up with outstanding tasks (see Priorities below) and build the administrative infrastructure required for the ACE Office to run smoothly.

Priorities to be given to the Recorder by President Monary were the creation of a new *ACE Web Site*; *ACE T-shirt* purchases; and eliminate backlog of CD requests for ACE Agreement by members requesting them.
