 - b. Meeting to be scheduled at De Anza on **May 12**, **2011** from 1:30 3 p.m in the Seminar Training Room. (Monica has scheduled these meetings via MeetingMaker and has invited the negotiations team. A notification will be sent to all Unit One members).
- 2. Shelley will send out pre-survey notification (without link) to Unit One.
- 3. May 18 May 20, 2011: Hold an online survey of all Unit One classified staff between.
- 4. **May 25:** Upon gathering the results of the survey (and suggestions from ACE membership), the negotiations team will decide which articles are the most important to Unit One classified staff. Those articles will be recommended for a vote to ACE full members at two General Membership meetings (one at De Anza & one at Foothill during working hours).
- 5. Following the two voting meetings, Negotiating Team will work on proposals for the articles voted.
- 6. Sunshine to the district July 1, 2011

Al volunteered to arrange to have food at the informational meetings. No votes were taken.
