Negotiation Report

Chris W. – Now we are following up with the District on some open items. I sent the sunshine letter earlier this week to Marietta. We met with the other units to determine how we want to proceed with bargaining the health benefits. Bargaining unit is only paying a composite rate and we have been paying increases with employee contributions. This year we used some of the one time fund to offset the cost to our members. We proposed raising

the composite rate and maybe using some one-time funds to siphon back into the stability fund. VEEBA is an option but there isn't much in it at this point. We want to increase funds by possibly getting some one time funds from the District.

Dave Garrido – Using one time to put it in the reserve is a good idea because we can take one-time funds and turn them into ongoing funds.

Matt – Deanza is proposing to use the carry forward money to create 6 new positions that would be funded for 4 years. This would include 2 A&R positions, a grounds position and tech trainer position. They discussed the Flint Center Parking Lot – They are not going to do anything at this time.
