## **Presidents Update**

### **Negotiation Report**

Chris W. – They will not be doing anything until medical benefits are agreed on by all the groups in the JLMBC. There, we are asking for an increase in what the District pays for individual benefits and a \$2 million increase in one-time funds to the VEEBA. They have one-time funds and can do it but their response gave us very little.

Christine Mangianeli – Meeting again in February. Have an actuary and bank account in place, as well as the third party administrator. We are starting to pay some bills. We had to pay the lawyers. We are happy with all the lawyers have done. It is looking effective if we can keep the money rolling in. It may be going out by next fall.

To be eligible you must have worked for the District for at least 15 years, full time or contract. You had to have been eligible for a medical plan, whether or not you are participated in it. You have to be 65 and Medicare eligible. Have to be post-97, July 1 on.

Now it is set up to pay the part B medical for Medicare. We need to increase the income going into it for it to work long term.

#### **ACE Recorder Position**

Chris W. – I went through what duties the recorder should be doing and tried to give the three best scenarios. We could get a member to do it. We could add a stipend to it. We could hire an outside person to be the administrative assistant and recorder. I am open to discussion.
