D. Financial Report

As of February 2014

- Net Positive Cash Flow of ~\$0.7K for February on Dues and Service fees of ~\$21.6K.
- Checking account balance is ~\$2.7K.
- > As of the end of February 2014, ACE has ~475.4 K in savings and investments.
- The PAC Income Statement and Balance Sheet for December are attached. PAC currently has a balance in the savings account of \$4,487.84.

ACE Investments

A. Perez has been shopping for CDs for some of ACE's funds. So far, the Luther Burbank Bank in Los Altos offers the best rates: 0.4% for one-year CDs (with a \$100K deposit) and 0.15% for two-year CDs (with a \$100K deposit). ACE currently has some funds in Well Fargo and East-West banks, but would be best served by diversifying where ACE funds are held.

During the next ACE Board Meeting, the Board will vote on how much ACE should spend on investments in light of ACE building costs.

The IRS has refunded \$200 to ACE. The original over-charge was due to accountant error.

Old Business:

Discussion of ACE Location/Building

B. Monary will meet with Vice Chancellor Kevin McElroy regarding a suitable ACE location on March 13. Mold abatement for one of the old trailers neighboring Plant Services may be cheaper than originally thought. Also, the Annex may be a potential location.

If there is no response from the District, B. Monary will meet with the FHDA Board and Chancellor.

ACE's new location depends on many factors, including rising construction costs, and where the Chancellor and ETS will be placed.

Student Employment

O. Patlan reported that, as of Feb. 6, 2014, Foothill has 172 unduplicated student workers; 49 of the students hold Federal work-study jobs, and 125 hold District-funded positions. De Anza has approximately 552 unduplicated student employees; 91 of the students hold Federal work-study positions and 469 hold District-funded jobs.

Some working students hold more than one job. Students may only work 19 hours per week total. Some student workers supervise other workers and perform jobs that could be classified positions.

There are many open questions regarding student employment:

- > Do some of the higher-level, specialized, and/or technical student positions belong to classified employees?
- > How many of the student workers work in these high-level positions?

O. Patlan will check in with Suzanne Pfeiffer in order to get answers; she will report back at the next Board Meeting.

Some Board members mentioned that some students may be seasonal, and others may hold two positions at two different times of the year (rather that simultaneously). Others expressed concern that some students are working more than eight hours in a shift, but not being paid overtime. There is a little oversight of these workers.

New Business:

Classification Poll

B. Monary suggested that the classification poll be delayed, since the ACE negotiation team should address this.

Cloud Research

M. Sain presented a summary of three different cloud companies - Box, Dropbox, and Google Drive. She discussed the costs, features, security, and other details (see notes below). She will also look into scanning + cloud services. There are companies that can take all of ACE's paper files, scan them, and store them. M. Sain will look into these companies and A. Perez will find out what company the purchasing department will use.
