Financials

The Board discussed the following:

How much money should ACE keep in reserve? Could ACE's current savings be used to reward the ACE membership? Although it is important to keep some money in reserve due to the

current ACE office crisis, the rest could be used for catering for meetings and Opening Day. Some of the cost of Opening Day catering may be shared with the Faculty Association. Food tickets would be a good idea for this event; M. Sain can send the tickets via snail mail in order to prevent meal ticket fraud.

Negotiations Report

The ACE contract will expire in October. ACE currently has no Negotiations Chair. A member has inquired, but has not yet committed. ACE will give the District a proposal by June 2014. But, this date may be pushed back if Suzanne Pfeiffer's resignation affects the negotiations process.

Other discussion:

The District might create a bullying policy. There is a new Ed Code law requesting that colleges create bullying policies for all; the language from the new law should go into the ACE contract so that it can be grieved.
