M. Sain Working out of Class

M. Sain will be working out of class as an Academic Services Technician in the Instruction Office at De Anza from Aug. 12, 2013 - June 30, 2014. During this time, an affected ACE member may provide back-fill for M. Sain's position (ACE Recorder/Admin. II). The affected employee has had her contract cut by 50%, and taking on the 50% Recorder position would give her a full-time schedule. However, the District must agree to this arrangement.

Negotiations Report

ACE sent a report to the District to negotiate the COLA; the District hasn't yet responded. ACE needs two new De Anza negotiators; one ACE member is considering becoming a negotiator.

Benefits/JLMBC - Benefits Trust

The price of the high-cost PPO has been decreased. Also, the VEBA Trust has hired a new lawyer, and will need to hire an actuary and some other professionals. Progress is being made, albeit slowly.

Budget - District, FH, DA

The budget forecast is looking brighter, but there is a 4% deficit factor, which is significant. And unfortunately, enrollment is still down - this will prevent FHDA from being in a good fiscal position for long time. Senior staff has promised that there will be no more layoffs this year.

Miscellaneous

Professional Development

Maureen Chenoweth reported on the state of professional development for California Community College classified staff: It was optional for a long time, but recently there was discussion of making professional development a five-day, mandatory process. However, recently, the Chancellor of the CCC system decided to cancel this plan. Maureen will further discuss this situation with the Chancellor in order to find out why he made this decision.

Work Distribution, Reclassification, and Working out of Class

There was also discussion of where some of the work has gone after the last round of layoffs. A. Perez expressed concern about how certain duties are being redirected to Gilbane. B. Monary mentioned that redirecting the work to Gilbane is against the ACE Contract, and that ACE can file a grievance.

O. Patlan suggested that ACE hire a classification consultant to give workshops to the membership, since the reclassification process is confusing and inconsistent.

There was also discussion of bargaining the working-out-of-class process to make it more equitable. However, ACE has already tried to bargain the process to be offered by seniority, and the District wouldn't agree to it. But, ACE was able to bargain a one-year limit to working-out-of-class assignments.
