Political Action Committee

There was discussion about the need to work on funding our Political Action Committee (PAC). Currently we still have \$5600 left to pay when we borrowed against dues for the work on the Parcel tax. There are nominal donations coming in but we need to have a more viable PAC. ACTION ITEM: Need to ask for volunteers to help manage this, and create a PAC committee. Blanche could send a request to members as a starting point.

Negotiations Report

Negotiations: We have submitted all of our proposals to the district except Article 15, which both parties agreed not to tackle until after the holidays.

With the departure of our district human resources director, the Vice Chancellor of Human Resources, Dorene Novotny has agreed to negotiate Article 8, compensation, and hold off on all others until the new HR director is hired.

ACTION ITEM: Chris White, Chair of Negotiations will send a letter to Dorene agreeing to those terms and reaffirming that our existing contract stays in effect until a new contract is negotiated or we reach an impasse. Everyone in favor, three were abstaining.

The agreement to PGA that we negotiated and signed with the district in Nov. 2014 still has not been approved by the district Board of Trustees.

ACTION ITEM: Chris White, Chair of Negotiations needs to send a letter to Dorene Novotny, Vice Chancellor of Human Resources to request that action be taken on this agreement.
