Negotiations Report

IPBT

IPBT met on October 7th and discussed the fall calendar and faculty hiring. Faculty Obligation Number is technically over by 50. While this poses a problem to faculty, the hiring doesn't affect ACE directly. Resignations and other actions are anticipated.

Composition of IPBT: M. Trosper and B. Monary discussed how the position of Union Vice President is assigned to the IPBT committee. According to Law, ACE must be represented first and the classified senate is second in any committee open to classified members.

Benefits/JLMBC

Stanford medical care will be unavailable to all our member plans. This is a major concern for some members because of Stanford's innovative experimental treatment options (see notes)

O. Patlan pointed out that directions given to members during the Benefits fair is misleading. If members attempt to roll-over information regarding allocation of beneficiaries, the basic information section will automatically reset to NONE- removing previously submitted beneficiary information.

Student Employment

Student employment for the purpose of work study and international students who are bound to work solely on campus are acceptable. Student employment brought in to replace a laid off worker or supervisory work otherwise intended for a classified position is not acceptable.

Benefits

One member contacted B. Monary regarding termination of medical benefits at Stanford. Anthem, Blue Cross and Stanford are having a hard time coming to an agreement for medical care negotiations closed in September and just recently re-opened. Stanford may not be available as an option to any of our member plans. The concern is how abrupt the interruption of medical care will affect our members that have initiated innovative treatments at Stanford. Deadline for enrollment closes Friday, October 10th.

Old Business

ACE contacted five candidates for the Classification Specialist position. One candidate in particular was interested in the position but she backed out at the last minute. While the search for classification specialist without HR manager influence continues, member C. White suggested consulting the Hay Group. The Hay Group has expressed conflict of interest since they have worked with the district on previous projects.
