UHC Reimbursements

\$157,000 is the total amount overcharged - the lowest reimbursement is 70 cents, and the highest is \$850. The District will reimburse this cost (note: the District will send a minimum of \$20; for instance, if UHC overcharged a member by 70 cents, that person will receive a \$20 check).

<u>Insurance</u>: River Valley Insurance

The Board reviewed the questions on insurance company's form to ensure that ACE is in compliance with insurance requirements (in order to avoid paying extra in premiums).

Topics of concern:

- Checks (is electronic payment in compliance with insurance rules?)
- Absences: River Valley Insurance requires us to report whether any Board member has missed more than three Board meetings (River Valley Insurance does not mention whether it matters if the absences are excused or not, nor what constitutes the aforementioned). For this reason, we need documentation of why Board Members are absent. If any Board member is to be absent, email Blanche.

If we aren't in compliance with River Valley Insurance's rules, it won't necessarily nullify the agreement, but we need to be careful in order to avoid giving the insurance company a reason to avoid coverage.

When Bradley returns, the Board will discuss this matter with him.

New ACE Location

In order to comply with fire codes, ACE office needs to move from its small faculty office to larger location. Also, the current set-up isn't ergonomically sound and the District agrees that ACE should move. Originally, Blanche had requested a move to the

Other Options:

- ACE might receive a portable.
- ACE can build its own temp building (\$80,000) out by the creek and field.
- If it's available, we can clean out the trailer next to the Carriage House and use that.
- Since District has nowhere to put us, we can buy a building.
- We can purchase a trailer and have the District install it. This would give us a place for 7 years.

- Faculty lounge
- · Where President's Conference Room used to be.

The Board ultimately decided to do a careful search to make sure we know of all options. After all, we need to be near the District, so that we can be in communication with them..
