<u>Recorder Board Policy</u> The following Board policy was proposed, but not approved.

Blanche Monary presented new Board Policy regarding the Recorder position: "As specified in the MOU signed with the District regarding the ACE Recorder position on March 2, 2011, the ACE Board created its own agreement with the Recorder position that serves ACE as a 50% or 20-hour-a-week position. The ACE Recorder has all the same rights and privileges afforded to all ACE employees under the ACE Contract.

Approved: the 26th Day of January 2012. Board Policy #1"

Bradley Booth advised that ACE not approve the Board policy for the following reason: ACE cannot contract with ACE, but the Recorder has all rights of the contract through the District (if terminated/laid off by ACE), but not while employed by ACE. This is an employee of the District with 100% release time just like the President. The difference is the President had a position she occupied when she left and Monica did not have a position because she was to be laid off from her position.

As a result, the Board decided to leave the Recorder position as it is.
