Stipend Survey Results

On Monday, May 11 2015, ACE surveyed members with the following question:

"ACE is considering stipends similar to FA as in the following quote in the FA newsletter dated April 27, 2015 Page 2: "FA Council Members are paid \$100 for each Executive Council meeting (typically two per month) and \$25 for each liaison/committee meeting report."

ACE meetings are held monthly. Would you agree or disagree?"

ACE received a total of 57 votes (approximately 15% of member population)

44 members voted **AGREE**, **12** members voted **DISAGREE**, and **1** member requested more information and remains undecided.
