Negotiations Report

College Council

IPBT

Summer Hirings are on the way for Classifieds using Service Excellence/Staff Development funds.

PARC

Discussions about Emergency Hires due to retirements & movements within faculty positions. Discussion of course completion goals = 77% - up from 76.9%.

<u>Budget</u>

Discussion regarding "unfunded mandates" changes- many charges received money for services rendered this year due to prop 98 funding.

Benefits/JLMBC

Dental implants will be removed. Maximum per year will be raised to \$2K per person- up from \$1500. A conversation then began about protecting the current plan costs since there is enough money saved up to cover any increases before the next year.

Campus Budget

This meeting discussed the Mandate Backlog from Prop 98 deferrals. The Prop 98 money will be used to implement new hires and cover other campus wide mandates discussed by IPBT and several other meetings attended by ACE Board members.

<u>SSPBT</u>

The meeting topics included staffing requests for the upcoming year (4 in A&R, 3 Enrollment Specialists, and 1 Evaluation Specialist position). A discussion then ensued between members on how to get departments back to pre-budget cut levels with Prop 98 funding.



H. Old Business

Dave Garrido's survey will be discussed at the board meeting retreat so the members can discuss the survey in depth. A conversation then ensued regarding the stipends and how the stipends would affect the budget while the Recorder counted the votes in the presence of the board Members. Results are included in the Enclosures section of this document. A conversation began discussing possible methods for implementing the stipends and requirements for receiving the stipend. A complete outline of stipends will be available at the upcoming board meeting in August.

General Membership Paper Ballot Results

On Tuesday, June 9th and Wednesday June 10th 2015, ACE conducted a paper ballot vote and asked its members to vote agree or disagree to the following question:

"Do you support Stipends for ACE Board members and Negotiators?"

ACE received a total of 65 Votes (approximately 20% of member population 19.519~%)

- Total Disqualified: 5 (Service Fee Payers (4), Qualified Member didn't check agree or Disagree (1) Non Member (1)
- Total Qualified Votes: 59
- 54 members voted AGREE (91.52542372881356% of qualified Votes)
- 5 members voted **DISAGREE (8.47%** of qualified Votes)
