#### H. Executive Board Decisions by Email:

The ACE Executive Board approved to suspend the ACE Constitution, Article 10.7, which requires elections be held open from 4-days, to two (2) days for the current 2015-16 Ratification Vote due to a technical malfunction with the ACE online voting system, and a need to run a paper ballot without impacting pending retirements. ## I. President's Announcements:

Currently submitting names of companies to preform classification study. Don't have many companies to choose from, but will continue to move forward.

#### J. Committee Reports:

Negotiations Report: Presenter Chris Dubeau
 JLMBC will meet in June. Reopener starts in the fall. No increase to employee health benefit cost unless district cost increases over 9%.

## VEBA – Benefits Trust: Presenter Christine Mangiameli

Will meet again in June. We completed the final versions of the MOU, the trust and the benefit plan documents. Awaiting final actuary report with the influx of the 800K from the district, so we can determine a monthly benefit.



College Council: Presenter Matt Trosper

Talked about accreditation and different groups writing. Discussed the possibility of revising the district mission statement.

• PARC: Presenter Denise Perez

Discussed College master plan. Talked about a possible study on moving department locations. Reviewed program application for an ADT in public health.

• Budget – District, FH DA: Presenter Chris White

District presented a plan on how to fund new boardroom. Funds will come from measure C. The facility maintenance account will be utilized to cover any overages. Flint center goes offline in Summer Session

#### Other Committees:

HRAC, Equity, PBTs: Presenters William Baldwin and Irma Rodarte

- Last met on April 28. Continue to work on getting EO plan completed. A completed EO plan potentially brings in 45K in state funding.
- Pat Hyland met with state civil rights reps to talk about equity in HR. There was a question as to how our district identifies disadvantaged groups.
- There is a need for a systematic approach to the EO plan.
- Bill solicited direction from board on what the classified want in equity and hiring committees?
- To ensure fair hiring practices the EO and ACE reps should be assigned from outside the hiring department.
- Each member of a hiring committee should have a copy of the regulations and procedures. It is suggested that the EO rep choose the committee members rather than the hiring manager.

#### New employee orientation:

HR is still trying to figure out how to implement new employee orientation. There
is concern that this process, which is contractually mandated, is taking too long.
Chris White will follow up with HR on their progress.
