- Enrollment for Spring is down about 7% districtwide 2.8% at Foothill and 5% at De Anza
- Foothill's second Spring session has generated 179 FTES as of May 3rd with the goal to try and recoup some of the loss from the elimination of early summer session.
- The district has enough one-time money to get through 2017/18.
- After 2017/18, if enrollment doesn't recover, there's not enough one-time funds to move forward without cuts.
- Researching how much is spent on district funded student workers and TEA's.
