# Anthony and White attended the conference on higher education.

- Was disappointed with the experience. Primarily focused on faculty. The one area discussed affecting classified staff – classifications – is currently being addressed through our classification study.
- Made suggestions for improvement.

### • Classification study

- Should have draft classifications by the end of January.
- Updated timeline of finishing by June 2017.
- Consultants suggested some agencies to use for the compensations part of the study but still needs to be reviewed by the JLMCC and negotiated.

## • **District Budget:** Presenter White

- District must cut \$10Mil.to cover structural deficit.
- District has one-time funds to get us thru the next two years but cuts must be made.
- Foothill is maintaining or up a little in FTES.
- De Anza took a major drop in FTES and is still on a downward slide
- De Anza will be adding more online sections, considering block scheduling, contacting students that applied but didn't attend and looking into enhancing dual enrollment.
