## • District has offered a supplemental retirement plan (SRP)

- Amount is 60-65% based on member's pay.
- They are offering faculty 75% as there is more savings for the district in the faculty area.
- District has been unable to provide employees with dollar amounts.
- Employee must submit application by 5 p.m. on Nov. 2 FHDA Board of Trustees will decide to approve or rescind the SRP at their Dec. 14, 2018 meeting.
- District has option to rescind the offer if it's found that the savings will not benefit the district.
- There needs to be additional planning and documentation on the process.
- District has planned to use part-time employees to fill the gaps for one year, however, bargaining units have not agreed to this.
- Those on staff development leave who want to take the offer may not be required to pay back the salary issued to them during their leave. FA has an MOU on this. ACE will working on a similar agreement.
