- There are 3 reasons we should move to another bank
 - 1. We currently don't earn interest.
 - 2. Accounts with balances over \$250,000 not FDIC secured.
 - 3. East West is not responsive to our needs
- K. Nguyen did some researched and found better interest rates.
- Currently in the process of setting up accounts with Citibank.
- Though we are not in the business of making money for profit, we have a fiscal responsibility to make our money work for us.
- Especially now that current and potentially new employees could opt out of membership, this may offset some of that lost revenue.

Classification Study:

- Joint Labor Management Classification Committee meeting next week.
- We have the consultant's draft report as well as the compensation portion of the study.

F. **President's Announcements:** Presenter White

- Working with Bradley Creamer to move website server platforms, as there are more affordable options since we set ours up in 2015. Also reviewing online voting platforms as our current system, AVOS, is tied to Foothill's server and we need to be independent from the colleges.
- As we move forward with cuts: I've been working with HR to create support workshops for staff. Looking at workshops called Staying Strong and Resilient, Managing Change for Employees and A Balanced Retirement.
- Both colleges and Central Services have finalized their budget reduction plans.
 - De Anza has no filled positions being eliminated.
 - Central Services has one filled position that they are eliminating.
 - Foothill has two positions with no bumping rights, however one is applying for other positions and one has chosen to take the reduction.
 - For positions that will be reassigned, we need to be sure that the work is appropriate to the classification. I have contacted HR to inform them that they need to notify us of any reassignments.
- o More reductions in the next year are likely due to the implementation of AB705. Foothill has implemented it this year for math only and saw a decline in enrollment. Next year they implement for English. De Anza has to implement both math and English next year, which most likely will result in additional declines in enrollment.
