- **Legal update:** Presenter B. Booth
  - Lawsuit filed against CalPERS regarding the 5% temporary salary increase being included as part of CalPERS retirement.
  - A court date for February 21, 2020 has been set to determine if we should be in front of a hearing officer at the CalPERS or are we properly before the court. Once that is decided we can then have a hearing on the merits, either before an administrative law judge at CalPERS or in court in front of a judge.

- There is some concern that the classification specs are sometimes interpreted for the convenience of the hiring process. We need to be sure that we are reading the specs carefully.
