• 2020-2021 Dues Forgiveness:

- Board previously voted to forgive dues for April May & June of 2020.
- We still have about \$90K in unallocated funds.
- Received a 53% response rate to the recent membership survey regarding the financial impact of the shelter in place (SIP) order.
 - More than ½ of the responding members indicated that working from home due to the SIP has had a negative financial impact.
- To help alleviate the financial needs of our members we should continue to forgive dues. The question now is for how many months?
- o I don't predict that we will be returning to campus before Jan. 2021, and with nearly \$90K of unallocated funds in our savings account, I don't foresee this as having a negative impact on our operating budget.
- Meggerson proposed we forgive dues for 3 months with the option to extend another 3 months.
- In the interest of saving time and effort, Kathy Nguyen recommends forgiveness of dues for 6 months ending Dec 2020.

E. **President's Announcements:** Presenter White:

- State Budget: Gov. didn't cut the 8% that they had planned on and extended the hold harmless for another couple of years.
- Challenges: Loss of enrollment, how many international students will come back?
 - The district is currently budgeting for a 30% drop.
 - o International students can take classes online so we'll have to see how many do for the Fall term.
- FHDA Board of Trustees approved eliminating positions in dinning services at De Anza. ACE has one member in that group however the position is vacant. We also have one classified hourly position in a program that is closing. We are waiting to see if the district will find placement elsewhere for the impacted employee.
- o Due to COVID 19, our annual audit has been pushed backed. We're waiting on the auditors to let us know when they can begin. I anticipate we will have 2019/20-year audit results sometime in Oct. or Nov.
- o There is a district budget task force whose purpose is to provide a guiding framework for budget reductions. They will not be making decisions on what gets cut (that is at the colleges) but they will prepare the framework. The group is made up of college and district senior leadership, as well as leaders from each bargaining unit and the senates.
 - A sub taskforce was established, from volunteers of the larger group, to develop a recommendation for the guiding framework. Sushini Chand and Andre Meggerson are representing ACE on that sub task force.
- Baldwin: We will be utilizing software for contact tracing. The software will ask health check questions and track where a person goes on campus. The data will belong to the college.

 - We have a tentative agreement that we will not see any increase to our health care contribution rates.
 - Though PERS has not yet released their rates, we've agreed that as long as the rates are not above a certain number the increased cost will not be passed on to the employees.
