Proposed Changes to ACE Constitution

- **District Budget:** Presenter White
 - o Must reduce budget by \$14 million over the next two years
 - o The colleges are to bring cuts to the Board of Trustees by May
 - We have a one-time pot of money that should cover positions for the next year
 - o We will have more information in May/June
 - o The Board of Trustees is asking why they haven't acted on anything
 - o They are looking at a parcel tax or bond
