A. Welcome:

- Chris White welcomed everyone.
- Members introduced themselves.

B. Approval of Minutes

- Motion: Approval of July 14th, 2021 minutes.

C. Financial Report:

D. 2021-2022 Tentative Budget:

- We were able to forgive dues for a whole year, spent \$100k from savings, but still able to do everything we needed to.
- Expenses were lower because of the COVID closure; pizza, fewer board members took stipends.
- Spending was similar to previous years.
- Recommendation: Forgive dues in December and May.
- Reminder: ACE will pay half of the cost of the classification study appeals, per agreement. They vary in price.
 - Discussion took place about how to handle future classification studies.
 - How they should be negotiated and how the process should work.
 - William Baldwin asked for clarification on the numbers.
 - Motion: Approval 2021-2022 budget with forgiveness of dues Dec & May. Moved: Baldwin Second: Chacko Motion approved unanimously

E. Officer Elections:

- Nominations are in October, elections in early November.
- Christine Mangiameli is retiring; her seat will be vacant. White will sit in on VEBA until a new board member is elected.
- Chris White is not running for president again.
- Conversations with colleagues are encouraged about running for positions. ACE doesn't work without its members serving on committees, negotiating, and actively engaging.
- Anthony Booth praised Chris White for her work in making ACE as strong as possible and increasing overall participation.
- Chris White praised the work of our lawyers and their continued guidance.

- Bradley Booth emphasized how ACE is different from SEIU; an Independent, nonprofit organization. Workplace workers controlling the destiny and resources that we have available. It's good to regularly reflect on the advantages of our current system vs. the old. Independence is crucial to the work we are doing. Without participation, the organization dies.
- Chris White commented: we would never be able to forgive dues if we were part of a national organization. We only spend what we need. When there is not a need, we give dues back.

F. President's Announcements: Presenter White:

- Discussion regarding making the September site meeting an in-person event to celebrate "re-union" with the membership. Christine Mangiameli, Angelica Moreno and Phuong Tran agreed to help coordinate.
- Finances are on a fiscal year; elections are on a calendar year. Changes may be necessary to the constitution to align the two which would improve operations.
- Bradley Booth commented that there should be a committee that should work on the constitution. Discussion will take place at future meetings regarding this.
- Chris White commented on how to improve operations and communication going forward. Explaining the VEBA, succession planning, etc.
- Christine Mangiameli commented on the value of creating things like the VEBA that benefit our members.
