- Finalized benefits negotiations.
- Set dates to meet for the 2021 year that starts next week
- The 2.5% that was to end June 30th has been extended for the year.
- State released their budget and there is a ton of money on the table
- FHDA is in a transition and will likely become a basic aid district, which will alter how we negotiate in a good way.
- We will be dealing with that over the summer and then will send out a negotiations survey to the membership for the 2021/22 year.

• **JMBLC:** Presenter White

- We finalized benefits and I will be sending that out to the membership latter this week or early next week.
- Question: Will the cola be negotiated as fully pensionable?
 - That is always our goal. One of the benefits of being a basic aid



- district is that it makes it a much easier goal because we know exactly how much money is at the table.
- The district is, and always has been, incredibly conservative and risk adverse; and I don't see that changing. They won't make any deal until they absolutely know where they stand.
- o B. Booth: I'd like to add that we did file a lawsuit with PERS over their determination that the 2.5% wasn't pensionable. That lawsuit was dismissed but was placed with PERS. We will have a hearing in front of a hearing officer. If we are not happy with the decision we will go back to court. There is no speedy response. We have two systems that are treating the exact same money in different ways. PERS says it's non pensionable STRS sys it is, and the language applies to both institutions the same. So, at some time we will get a court to make that determination for us.
