MEMORANDUM OF UNDERSTANDING

BETWEEN
FOOTHILL-DE ANZA COMMUNITY COLLEGE DISTRICT
AND

THE PARTICIPATING UNIONS OF THE JOINT LABOR MANAGEMENT COST OF LIVING ADJUSTMENT (COLA) COUNCIL ("JLMCOLA") COMPOSED AS FOLLOWS:

CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION,
FACULTY ASSOCIATION,
POLICE OFFICERS ASSOCIATION,
AND TEAMSTERS

This Memorandum of Understanding is entered into by and between the Foothill-De Anza Community College District (District) and the following Unions: the Association of Classified Employees (ACE), the California School Employees Association (CSEA), the Faculty Association (FA), the Police Officers Association (POA), and the Teamsters. The District and the Bargaining Units mutually agreed to participate in Joint Labor/Management Cost of Living Adjustment (COLA) ("JLMCOLA") bargaining for the 2023-2024 fiscal year.

The following shall constitute an agreement between the Unions and the District on the topic of COLA and salary adjustments for the 2023 – 2024 fiscal year.

• Effective July 1, 2023, each ACE, CSEA, FA, POA, and Teamsters salary schedule shall increase by 7.22%.

Terms: The salary adjustments to all of the respective groups' Articles on salary and salary schedule appendices (ACE: Article 8 and Appendix C; CSEA: Article 5 and Appendix A; FA: Article 24 and Appendices A, B, B.1, C, C.1, D, D.1, E, and G; POA: Article 6 and Appendix C; and Teamsters: Article 6 and Appendix C) shall be effective July 1, 2023, using the Banner system calculated salary tables. This will enable the District to expeditiously implement the salary increases.

The bargaining units retain the right to validate the values in the Banner calculated salary tables. If a discrepancy exists, the bargaining unit and the District shall reach mutual agreement regarding the final value(s) in the salary tables. Implementation shall commence as soon as possible following Union ratification, where required, and approval by the Board of Trustees. Given the short timeline, and as this requires additional programming and system modification, the parties agree to not commit to a specific deadline for implementation. The District will make a good faith effort to implement as guickly as possible.
