• FY22-23 Layoffs:

- Layoffs have concluded and were all due to the elimination of grant funds.

• August Board Meeting: Meet or Retreat:

• Had some positive feedback for a retreat. Will invite negotiators as well as stewards.

F. Committee Reports:

- **Negotiations Report:** Presenter: White
 - COLA 6.22% spread over 2 years, but we are looking for a 1-year deal.
 - Articles being negotiated: Article 3, Article 7, Article 8, Article 9.9, Article 10, Article 11, Article 13, Article 16, & Article 18.
 - Some of these articles had to be open due to legal changes.
 - Negotiating is a process.
- JLMBC: Presenter: White
 - Still in the process of negotiating with the district. There will be a cost increase to employees.
 - CALPERS health benefits averaged a 10.4% increase. COLA is 8.22%, hence the need to use part of the COLA to cover district ongoing costs.
 - We did our due diligence in shopping providers (SISC, San Mateo Joint Health Consortium (?)); however, we've determined that leaving CALPERS, at this time, would not be cost beneficial to us. At some point we may need to have a larger discussion regarding how health benefits are funded, what is offered and/or who gets covered. However, that requires a lot more feedback from the membership than we currently have.
