G. Committee Reports:

- District Budget Committee (DBAC): Presenter Olsen
 - Haven't met since Jan 29th ACE Board meeting.
 - The district is under the funding floor and there is concern over the budget and potential revenue generation. We are currently frozen at the funding level we are at.
 - Meggerson suggested we ask DBAC if the district is pushing for chasing enrollment or if there is a focus on downsizing. Olsen explained he thinks both campuses are chasing enrollment and seeking revenue generating sources.
