G. Committee Reports:

- o District Budget Committee (DBAC): Presenter Scott Olsen
 - The District exceeded the funding floor so estimated COLA may be 1.5% instead of the 2.2% in the Governor's budget.
- o Negotiations Report: Presenter Scott Olsen
 - The first meeting with the district is at the end of July. Chris will provide a written update.
 - Thank you to Margarita Hawthorne, from De Anza, for joining the negotiations team, replacing Carrie Kirkpatrick.
 - A member survey asking about parking-related financial impacts may go out. Sharon Garcia-Vega suggested collaborating with faculty if there is any interest since employee parking also affects them.

 - Preliminary rates show Kaiser HMO increasing \sim 5.5% and the most expensive PPO up \sim 13%. More updates to come.
