D. Old Business:

- **Labor Notes Conference:** Presenter Scott Olsen
 - The Labor Notes conference will occur from Thursday, June 12th to Sunday, June 14, plus travel time. This conference is nationwide and has plenaries and breakouts on negotiations, bargaining, parental leave, etc. They have a keynote speaker and offer a chance for union networking.

- **Internal Roster Review:** Presenter Lisa Ly
 - Lisa Ly requested access to the existing ACE roster to explore membership patterns by site, years of service, etc. to help inform engagement strategies, future site topics, and negotiation priorities.
 - Chris Chavez shared the anonymous negotiations survey with Lisa Ly since it also includes some demographic information and may help inform her data review.
 - Scott Olsen shared that there are 410 ACE positions at FHDA with a 90% join rate.

F. President's Announcements: Presenter: Scott Olsen

- **Employee Housing**
 - FHDA has acquired units for employee housing at The Sevens housing complex in Mountain View but eligibility criteria regarding income is still being negotiated.
 - The district is proposing an occupancy limit of 5 years per employee. More details to follow via email.

G. Committee Reports:

- **District Budget Committee (DBAC):** Presenter Chris Chavez
 - FHDA non-resident international enrollment is only down 2% versus the national average which is down 19%.
 - There is an upcoming budget Town Hall next week.
 - FHDA remains comfortably in Basic Aid for the foreseeable future (property tax revenues \approx \$240M vs SCFF \approx \$190).
 - The district carried a \sim \$13M surplus from the prior year.
- **Negotiations Report:** Presenter Chris Chavez
 - Negotiations are moving forward in most areas except salary which has yet to be discussed.
 - The bilingual pay pilot is being negotiated to remove the position cap and the language cap.
 - The final meeting will occur next Thursday with the hopes of ratifying negotiations at the November board meeting.
